Requirements

- 1 1. Four color printing.
- 2 2. PVC Plastic cards. (As per sample)
- 3 3. Two years guarantee of printed cards by the vendor that color & quality of the printed cards will not be faded/ affected.
- 4 4. Estimated cost of cards Rs: 1,600,000/- (One million six hundred thousand rupees only)

The bids shall accompany 2% Bid Security (Estimated) in form of a CDR/Bank Draft/PO in favor of **The Punjab Educational Endowment Fund**.

The sealed bids must be submitted on or before Monday May 29, 2017 **at 1200 Hours** to the undersigned in a sealed envelope marked with the name of item.

The bids will be opened on Monday May 29, 2016 **at 1400 Hours** on the same date in the presence of bidders and/or their authorized representatives.

**Instruction to Bidders
&
General Terms and Conditions**

- 1 1. Only sales tax registered and N.T.N. holder firms may participate in the tender.
- 2 2. Rate of each item must be quoted separately inclusive of sales tax, where applicable. It should clearly be mentioned on the quotation letter that “the rates are inclusive of GST, PST and all other taxes”. If The Quotation letter does not bear the above mentioned statement, it shall not be considered.
- 3 3. Earnest money @ 2% of the total estimated purchase price in the shape of CDR/Bank Draft of schedule bank should accompany the tender otherwise tender will not be entertained.
- 4 4. The office Tender Committee will open the tenders in the presence of the bidders or their representatives.
- 5 5. 2% earnest money is refundable and will be returned to the unsuccessful bidders after the award of purchase order to the selected bidder.
- 6 6. Quotation filled by the bidders with over writing/ tempering/ cutting/ erasing will be canceled.
- 7 7. Income tax will be deducted at source as per government rules.
- 8 8. Quantity of supply may change according to PEEF requirements. The supplier will be bound to accept the repeat orders as per quoted rates till June 2018.
- 9 9. Delivery of the desired goods/services will be completed after the issuance of purchase order and agreed timelines between both parties.
- 10 10. It will be the responsibility of the supplier to take back the supply declared not according to the specification at his own risk and cost.
- 11 11. Tender envelop must be signed and stamped by the competent authority of the firm otherwise tender will not be entertained.
